A) Chief Scott Sewell reported the activities by the police department for the month of December as 280 traffic citations issued, 3 misdemeanor arrests, 3 incident reports taken and 9 crash reports filed.

B) Mayor Carter reported there were several water leaks and sewer mains repaired, trees cleaned up from the ice storm and roads were being scheduled by Roger Petty to be repaired.

C) Chief Tommy Faulkner reported the Volunteer Fire Department had 10 active members and there were 341 calls in 2013 with 103 in the City and 238 within the district. There were 55 grass fires, 140 medical calls, 1 car fire, 17 structure fires, 63 motor vehicle accidents, 23 investigation calls and 32 public assistance calls.

Mayor Carter called the meeting to order at 3:00 p.m.


II. OFFICIAL CANVAS
