CITY OF CUMBY CITY COUNCIL MEETING DECEMBER 1, 2009

THE CITY OF CUMBY, TEXAS MET IN REGULAR SESSION ON TUESDAY, DECEMBER 1, 2009, AT 7:00 PM AT 100 E. MAIN STREET, CUMBY TEXAS.

THE FOLLOWING WERE PRESENT: MAYOR JEFF STRICKLAND, COMMISSIONER LEON HIGGINBOTHAM, COMMISSIONER TRAVIS BAXLEY, ANGIE ALLEN, LA NORA POWELL, CHIEF SCOTT SEWELL.

- 1) MAYOR STRICKLAND CALLED THE MEETING TO ORDER.
- 2) COMMISSIONER HIGGINBOTHAM MADE A MOTION TO APPROVE THE MINUTES FROM THE PREVIOUS MEETING. COMMISSIONER BAXLEY SECONDED THE MOTION. ALL APPROVE. MOTION PASSED.
- 3) PRESENTATION FROM THE CITIZENS: NONE
- 4) OLD BUSINESS:
- A) STREETS: THE CITY WILL ORDER & POST 6 NEW CHILDREN AT PLAY SIGNS.
- B) WATER FACILITIES: WELLS PUMPED 2,777,800. WATER SOLD 1,941,400. THE WWTP & CHURCHES USED 213,370. THERE WAS A LOSS OF 623,030. 198 POUNDS OF CHLORINE WERE USED. THE COST WILL INCREASE BY \$4,000.00 DOLLARS ON THE REPAIR OF THE EXISTING 50,000 GAL WATER TANK, DUE TO THE TANK NEEDING TO BE LEVELED.
- C) SEWER PLANT: ROGER PETTY IS LOOKING FOR A TRANSFER PUMP THAT NEEDS TO BE REPLACED. NO TRESPASSING SIGNS NEED TO BE POSTED AT FENCE OF WWTP. FENCE NEEDS TO BE REPAIRED AS WELL.

 - A) RESOLUTION / ACCEPTING 2009-2030 COMPRENHISIVE PLAN/ CONTRACT # 728124: THIS RESOLUTION STATES:

- D) AUDIT PROPOSAL / RUTHERFORD & TAYLOR: THE CITY COUNCIL RECEIVED A BID FOR THE ANNUAL AUDIT FROM RUTHERFORD & TAYLOR. COMMISSIONER BAXLEY MADE A MOTION TO ACCEPT RUTHERFORD & TAYLOR AS THE CITY'S AUDITORS. COMMISSIONER HIGGINBOTHAM SECONDED THE MOTION. ALL APPROVE. MOTION PASSED.
- E) **RESCIND RESOLUTION 6-2007 / REST AREA:** COMMISSIONER HIGGINBOTHAM STATED TO THE COUNCIL THAT RESOLUTION 6-2007 NEEDS TO BE RESCINDED DUE TO THE FACT THAT THE TXDOT SCHEDULES FOR THE NEW REST AREA HAVE SINCE CHANGED. TXDOT HAS ALSO HAD PERSONAL CHANGES. MAYOR STRICKLAND STATED THAT THE CITY COUNCIL WILL HAVE A WORKSHOP TO RESTRUCTURE THE RESOLUTION. COMMISSIONER HIGGINBOTHAM MADE A MOTION TO RESCIND RESOLUTION 6-2007. COMMISSIONER BAXLEY SECONDED THE MOTION. ALL APPROVE. MOTION PASSED.
- F) **WESTBROOK BIDS:** THE CITY RECEIVED A BID FROM WESTBROOK FOR SIDE WALK WORK AT NANCY MELTONS ON MAIN STREET IN THE AMOUNT OF \$2,496.00 AND A 14x16 CONCRETE SLAB FOR NEW GENERATOR AT THE SEWER PLANT IN THE AMOUNT OF \$ 2,464.00. COMMISSIONER BAXLEY MADE A MOTION TO ACCEPT BOTH BIDS FROM WESTBROOK. COMMISSIONER HIGGINBOTHAM SECONDED THE MOTION. ALL APPROVE. MOTION PASSED.
