THE CITY OF CUMBY, TEXAS MET IN SPECIAL SESSION ON FRIDAY, MAY 14, 2010,
AT 8:00 PM AT 100 E. MAIN STREET, CUMBY TEXAS.

THE FOLLOWING WERE PRESENT: MAYOR JEFF STRICKLAND, ALDERMAN
CHUCK TUGGLE, ALDERMAN BILL JENKINS, ALDERMAN BRIAN SEELY,
ALDERMAN KATHY HALL CARTER, ANGIE ALLEN, CYNTHIA HUMPHRIES, AUDRI
MAYO, JILL CASTRO.

1) MAYOR STRICKLAND CALLED THE MEETING TO ORDER.

2) ELECT MAYOR PRO TEM: CITY SECRETARY ANGIE ALLEN DESCRIBED THE
DUTIES OF THE MAYOR PRO TEM. THEY ARE AS FOLLOWS: THE MAYOR PRO TEM
IS A MEMBER OF THE CITY COUNCIL WHO PERFORMS THE MAYOR'S DUTIES
DURING THE MAYOR'S INCAPACITY OR ABSENCE. THE MAYOR PRO TEM IS
SELECTED BY MAJORITY VOTE OF THE COUNCIL FROM AMONG ITS OWN
MEMBERSHIP FOR A TERM OF ONE YEAR. THE MAYOR PRO TEM RETAINS THE
RIGHT TO VOTE ON ALL MATTERS BEFORE THE COUNCIL (AND NOT JUST TO
BREAK A TIE) WHILE PERFORMING THE DUTIES OF THE MAYOR. ALDERMAN
JENKINS MADE A MOTION TO SELECT BRIAN SEELY AS MAYOR PRO TEM FOR
ONE YEAR. ALDERMAN TUGGLE SECONDED THE MOTION. ALL APPROVE.
MOTION PASSED. THE MAYOR STATED THAT THE 2ND YEAR MAYOR PRO TEM
WILL NOT BE SELECTED UNTIL AFTER ALL THE CITY COUNCIL IS ASSEMBLED.

3) APPOINT SIGNATURES FOR CITY BANK ACCOUNTS: MAYOR STRICKLAND
STATED THAT THE FOLLOWING WILL BE AUTHORIZED AS SIGNATURES ON ALL
CITY OF CUMBY BANK ACCOUNTS.

11TH AT 3:00 PM. THE FOLLOWING WERE PRESENT DURING THE RECOUNT:
CANDIDATE LEON HIGGINBOTHAM, RECOUNT SUPERVISOR/ COORDINATOR
ANGIE ALLEN, 1 COUNTING TEAM- WANDA WILLIAMS, JUDY MACHEN, NADINE
LITTON, GWENDA ROMANS. THE RECOUNT DETERMINED THAT THERE IS STILL A
TIE FOR ALDERMAN, PLACE 4 (ONE YEAR TERM), THEREFORE THE CITY OF
CUMBY WILL ORDER A RUN OFF ELECTION. THE ORDER IS AS FOLLOWS:




