THE CITY OF CUMBY, TEXAS MET IN SPECIAL SESSION ON MONDAY, JUNE 14, 2010, AT 7:00 PM AT 100 E. MAIN STREET, CUMBY TEXAS.

THE FOLLOWING WERE PRESENT: MAYOR JEFF STRICKLAND, ALDERMAN CHUCK TUGGLE, ALDERMAN BILL JENKINS, ALDERMAN BRIAN SEELY, ALDERMAN KATHY HALL CARTER, ANGIE ALLEN, LaNORA POWELL, RENEE SEELY, MICHELLE STRICKLAND, SCOTT SEWELL, ROGER PETTY, JOHNNY CARTER, RICKY DENSON, AUDRI MAYO.

1) MAYOR STRICKLAND CALLED THE MEETING TO ORDER.

2) **DISCUSSION / ACTION ON RESOLUTION ADOPTING THE CITY OF CUMBY EMPLOYEE HANDBOOK:** MAYOR STRICKLAND READ THE PROPOSED EMPLOYEE HANDBOOK TO THE CITY EMPLOYEES. ALDERMAN JENKINS MADE A MOTION TO ADOPT THE CITY OF CUMBY EMPLOYEE HANDBOOK. ALDERMAN TUGGLE SECONDED THE MOTION. ALL APPROVE. RESOLUTION PASSED. RESOLUTION NUMBERED 2010-3.

3) **DISCUSSION / ACTION ON AMENDING WATER RATE ORDINANCE 2006-10:** CITY SECRETARY ANGIE ALLEN READ THE PROPOSED CHANGE ON ORDINANCE 2006-10. IT READS AS FOLLOWS:

SECTION 2: The sewer rates for domestic customers within the corporate limits of the City shall be as follows:

- A) From October 1 through March 31 rates will be assessed as follows:
 - 1) 2,000 – 5,000 gallons \$15.50
 - 2) 5,001 \$ 2.00 per 1,000 GAL.
- B) From April 1 through September 30 rates will be prorated to reflect the average usage. Using the following formula:
The total usage for the 6 month period October 1 through March 31 will be averaged and this amount will be assessed for the six (6) month period of April 1 through September 30.

ALDERMAN JENKINS MADE A MOTION TO ACCEPT AMENDED ORDINANCE 2006-10 BY STRIKING SECTION 2 AND INSERTING SECTION 2 AS READ BY CITY SECRETARY. ALDERMAN SEELY SECONDED THE MOTION. ALL APPROVE. MOTION PASSED. THIS ORDINANCE WILL BE NUMBERED 2010-5.
