SPECIAL SESSION CITY COUNCIL MEETING
2:00 PM
SEPTEMBER 9, 2010

PRESENT: MAYOR JEFF STRICKLAND, ALDERMAN CHUCK TUGGLE, ALDERMAN KATHY HALL-CARTER, ALDERMAN BILL JENKINS, ALDERMAN BRIAN SEELY, CITY SECRETARY ANGIE ALLEN, LARRY BLOUNT, LARRY POWERS.

MAYOR STRICKLAND OPENED THE SPECIAL SESSION CITY COUNCIL MEETING.

MAYOR STRICKLAND STATED TO THE CITY COUNCIL THAT IT WAS TIME FOR THE CITY TO LOOK INTO CHANGING CITY ATTORNEYS. MAYOR STRICKLAND STATED THAT WE DO NOT HAVE A CONTRACT WITH OUR CURRENT CITY ATTORNEY. MAYOR STRICKLAND STATED THAT A LETTER WOULD BE DRAWN UP LETTING THE CITY'S PRESENT ATTORNEY KNOW THAT HER SERVICES AS CITY ATTORNEY & CITY PROSECUTOR WOULD NO LONGER BE NEEDED.

MR. POWERS HAS BEEN AN ATTORNEY FOR POINT & EAST TAWOKANI AS WELL AS BEEN ON THE CITY COUNCIL OF SULPHUR SPRINGS. MR. BLOUNT HAS PROSECUTOR EXPERIENCE.


THE LAW OFFICES OF BLOUNT & POWERS CHARGE AN HOURLY RATE OF \$200.00, AND DO NOT REQUIRE A RETAINER.

MR. BLOUNT WILL HANDLE THE CITY'S PROSECUTOR DUTY'S AT AN HOURLY RATE OF \$200.00. MR. BLOUNT ASKED THAT THE COURT CLERK FAX OR EMAIL THE COURT DOCKET 2 DAYS BEFORE COURT NIGHT.

THE CITY COUNCIL STATED TO MR. BLOUNT & MR. POWERS THAT THE COUNCIL DOES NOT REQUIRE THEM TO BE PRESENT AT CITY COUNCIL MEETINGS, UNLESS ARRANGEMENTS HAVE BEEN MADE PRIOR TO THE MEETING.

ALDERMAN HALL-CARTER MADE A MOTION TO HIRE THE LAW FIRM OF BLOUNT & POWERS TO BECOME THE CITY ATTORNEY OF THE CITY OF CUMBY. ALDERMAN TUGGLE SECONDED THE MOTION. ALL APPROVE. MOTION PASSED.

WITH ALL BUSINESS COMPLETE THE MEETING WAS ADJORNED.
