

ORDINANCE #92-1

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CUMBY, TEXAS, PROVIDING FOR AN INCREASE IN THE RATES CHARGED BY THE CITY FOR WATER UTILITY SERVICE AND STATING THE CURRENT RATES FOR SEWER, TRASH COLLECTION, AND FIRE TRUCK WHICH ARE ALSO BILLED ON THE WATER UTILITY BILL; REPEALING ALL ORDINANCES OR PORTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE ON JANUARY 1, 1992.

BE IT HEREBY ORDAINED BY THE CITY COMMISSION OF THE CITY OF CUMBY, TEXAS:

WATER RATES

THAT the City of Cumby, Texas shall charge the following rates per month for water provided to all domestic and commercial customers:

- a) Within the City's corporate limits:
  - 1) 0,001 - 2500 gallons = \$ 15.00
  - 2) 2,501 - or more gallons = \$ 1.75 per 1,000 gallons or part thereof
- b) Outside the City's corporate limits:
  - 1) 0,001 - 2,500 gallons = \$ 19.50
  - 2) 2,501 - or more gallons = \$ 1.75 per 1,000 gallons or part thereof.

II

SEWER RATES

THAT the City of Cumby, Texas shall charge \$ 14.00 per month to all customers connected to the City's sewer system.

III

TRASH COLLECTION RATES

THAT the City of Cumby, Texas shall charge \$ 5.00 per month to all customers subscribing to trash collection service provided by the City.

IV

FIRE TRUCK RATES

THAT the City of Cumby, Texas shall charge \$ 1.50 per month to all customers connected to the City's water system to pay for the purchase of a new pumper fire truck for the Cumby Volunteer Fire Department.

V

SAVING  
CLAUSE

THAT if any section, sentence, clause or phrase of this ordinance is for any reason held to be illegal, ultra vires or unconstitutional, such invalidity shall not effect the validity of the remaining portions of this ordinance.

VI

REPEAL

THAT this ordinance shall supersede any prior ordinance in conflict herewith, and such prior conflicting ordinances or parts thereof are hereby repealed to the extent that they conflict with this ordinance.

VII

EFFECTIVE  
DATE

THAT this ordinance shall be in full force and effect on and after January 1, 1992.
