

ORDINANCE NO. 96-4

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CUMBY, TEXAS, ANNEXING PUBLIC RIGHTS OF WAY TO THE CITY; EXTENDING THE BOUNDARY LIMITS OF THE CITY SO AS TO INCLUDE SAID AREA; GRANTING TO SAID ANNEXED AREA ALL OF THE RIGHTS AND PRIVILEGES GRANTED TO OTHER AREAS WITHIN THE CORPORATE LIMITS OF THE CITY; AND PROVIDING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT IMMEDIATELY UPON ITS PASSAGE AND APPROVAL.

WHEREAS, the City of Cumby, Texas has determined that the annexation of certain publicly owned rights of way adjacent to the corporate limits of the City and coming within the extra territorial jurisdiction of the City should be, in the interest of public convenience and benefit, annexed by the City so that said areas will thereafter be a part of and included within the corporate limits of the City.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Cumby, Texas:

SECTION ONE: The areas of real property within the public right of way of the following publicly owned highways, from the intersection of said public rights of way with the corporate limits of the City and extending for a distance of one (1) mile from the present corporate limits of the City shall be and the same are hereby annexed to the City of Cumby, Texas, and the corporate limits of said City are hereby extended to incorporate and include said tracts of said property within the corporate limits of the City, and said areas of real property shall hereafter be entitled to all rights and privileges of the City of Cumby, Texas, and shall hereafter be bound by the acts, ordinances, ordinances, resolutions, and regulations of the City, to wit:

Interstate Hwy. 30 West from the corporate limits of the City;

Interstate Highway 30 East from the corporate limits of the City;

The North and South service roads of Interstate Highway 30 East from the corporate limits of the City;

The North and South service roads of Interstate Highway 30 West from the corporate limits of said City;

Highway 275 in a Northerly direction from the corporate limits of the City;


Highway 275 in a Southerly direction from the corporate limits of the City;

Highway 499 in a Westerly direction from the corporate limits of the City;

Highway 499 in a Easterly direction from the corporate limits of the City to the intersection with Interstate 30.

SECTION TWO: This ordinance shall be in full force and effect immediately upon its passage and approval.


