If your offense is not listed above, please visit the cityofcumby.com under the Municipal Court drop-down menu to access fine amounts for other offenses. FINES WILL BE DOUBLED IF VIOLATION OCCURS IN A CONSTRUCTION ZONE WHILE WORKERS ARE PRESENT.

The following offenses may be dismissed, if requirements are met, and dismissal fees are paid.

1. **Insurance - Provide** proof of insurance for the date of the offense, **MUST** be presented within twenty (20) days of ticket date. Court will verify with company listed on provided proof. **(NO dismissal fee required)**
2. **Registration** – Provide proof of registration **WITH PENALTY PAID** at the time of renewal, **MUST** be presented within 20 days of ticket date. Dismissal fee of \$20.00 required. Must contact Court on or before appearance date.
3. **Expired Driver's License** – Provide Proof of valid Driver's License **MUST** be provided within 20 days of ticket date. Dismissal fee of \$20.00 required. Must contact Court on or before appearance date.

REQUEST FOR DRIVER'S SAFETY COURSE (DSC)

IF YOU HOLD A CDL LICENSE, OR IF YOU ARE CHARGED WITH SPEEDING 25 MILES OR MORE OVER THE POSTED SPEED YOU WILL NOT BE ELIGIBLE. A Driver's Safety Course can only be taken once every twelve (12) months for dismissal of a traffic violation.

A request to take a Driver's Safety Course must be received by the Court **on or before** your appearance date and **prior** to enrolling in a Driver's Safety Course. The following steps must be completed for your request to be approved:

1. Pay the NON-REFUNDABLE administration fee in the amount of **\$109.00 (must be submitted directly to the Court. **** DO NOT PAY ONLINE****)**
2. Furnish the Court with a copy of valid **TEXAS DRIVERS LICENSE**
3. Furnish the Court with a copy of valid **LIABILITY INSURANCE**
4. Furnish the Court with a **CERTIFIED COPY (TYPE 3A)** driving record from the Texas Department of Public Safety. Record may be obtained online at **www.texas.gov**

After approval to take Driver's Safety Course, you will have ninety (90) days (date to be determined by the court) to complete and submit a certificate of completion to the Court. If certificate of completion is not provided, the charge will not be dismissed, the fees will not be refunded and the full amount of the fine assessed will be due. If not paid, a warrant may be issued and additional fees may be added.
