

**ORDINANCE 2010-6**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CUMBY, TEXAS, LEVYING TAXES FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF SAID CITY FOR THE TAX YEAR 2010 UPON ALL TAXABLE PROPERTY WITHIN THE SAID CITY, FIXING THE RATE THEREOF; PROVIDING THAT SAID ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE IMMEDIATELY UPON ITS PASSAGE AND APPROVAL.**

**BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF CUMBY, TEXAS:**

**I.**

THERE IS HEREBY LEVIED, AND THERE SHALL BE COLLECTED, FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE SAID CITY OF CUMBY, TEXAS FOR THE TAX YEAR 2010. UPON ALL PROPERTY, WHETHER REAL, PERSONAL, OR MIXED, WITHIN THE CORPORATE LIMITS OF SAID CITY AND SUBJECT TO TAXATION, A TAX OF .3842 PER EACH \$100.00 VALUATION OF SUCH PROPERTY.

**II.**

THE TAXES HEREIN ABOVE LEVIED SHALL BE DUE ON THE LAST DAY OF OCTOBER, 2010, AND IF NOT PAID BE THE 1<sup>ST</sup> DAY OF FEBRUARY, 2011, SUCH UNPAID TAXES SHALL BE THEN AND THERE DELINQUENT AND SUBJECT TO THE ADDED PENALTY, INTEREST, AND COSTS AS PROVIDED BY LAW, WHICH SAID PENALTIES, INTEREST AND COST SHALL BE ADDED BY THE ASSESSOR AND COLLECTOR OF TAXES AS PROVIDED BY LAW.

**III.**

FOR THE PURPOSE OF ENCOURAGING AND INCLUDING THE PAYMENT OF SAID TAXES DUE SAID CITY BEFORE THE FIRST DAY OF JANUARY, 2011, PERSENTAGE DISCOUNTS ON FULL PAYMENTS SHALL BE ALLOWED AND ARE AS FOLLOWS, TO WIT:

FOR FULL PAYMENT IN OCTOBER, 2010	3%
FOR FULL PAYMENT IN NOVEMBER, 2010	2%
FOR FULL PAYMENT IN DECEMBER, 2010	1%

IV.

THE SAID ASSESSOR AND COLLECTOR OF TAXES OF SAID CITY SHALL KEEP SAID ACCOUNTS SO AS TO READILY AND DISTINCTLY SHOW THE AMOUNT COLLECTED, THE AMOUNTS EXPENDED AND THE AMOUNT ON HAND AT ANY GIVEN TIME.

V.

THAT IF ANY SECTION, OR PART OF PROVISION ON THIS ORDINANCE IS DECLARED UNCONSTITUTIONAL OR INVALID, THEN, IN THAT EVENT, IT IS EXPRESSLY PROVIDED, AND IT IS THE INTENTION OF THE CITY COMMISSION IN PASSING THIS ORDINANCE, THAT OTHER PARTS OF THIS ORDINANCE SHALL NOT BE AFFECTED THEREBY AND SHALL REMAIN IN FULL FORCE AND EFFECT.

VI.

ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THE TERMS OF THIS ORDINANCE ARE HEREBY EXPRESSLY REPEALED.

VII.

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE IMMEDIATELY UPON ITS PASSAGE AND APPROVAL, AND IT IS SO ORDAINED.
